Upon the application of these products to your vehicle, we guarantee the performance of these products as described below for a period of 9 years from the date of purchase. Every privately-owned non-commercial car or light truck is eligible, regardless of age.

### *Owners Pride Environmental Paint Protection Product*

If the Owners Pride Environmental Paint Protection product fails to protect the paint of the vehicle to which it has been applied from permanent damage by weather induced fading, weather induced chalking, weather induced loss of gloss, acid rain, bird waste, tree sap, sun's UV rays, de-icing agents/road salt, ocean spray, brake dust, rail dust, paint overspray, and fuel stains, we will (1) pay to repair the damaged, treated surface of the vehicle using industry-standard detailing techniques, and (2) will pay to re-apply appearance protection product to the affected surface, at no cost to you. Under no circumstances will we pay for repainting or replacement of affected surfaces, nor will we pay for the cost of alternate transportation while your vehicle is being repaired.

### *Limitations*

**THE TOTAL OF ALL CLAIMS UNDER THIS WARRANTY IS LIMITED TO \$5000. THIS WARRANTY WILL LAPSE, AND NO FURTHER CLAIMS WILL BE PAID, ONCE WE HAVE PAID \$5000 IN CLAIMS ON YOUR BEHALF.**

Claims made after the warranty has expired will be denied, even if the damage arose prior to the warranty's expiration date. Claims for damage that is more than 60 days old will be denied. Claims for damages other than those expressly identified in this warranty will not be honored. Damage existing at the time the products are applied is not covered by this warranty. We reserve the right to dispatch an independent vehicle inspection firm, at no cost to you, to assess the eligibility of the claimed damage for warranty coverage before approving the payment of a claim. Warranty coverage is available only to the original purchaser of the product. Repairs completed before a claim has been approved will not be reimbursed. Proof of purchase or product registration required to make a claim. We will pay for only one repair of each treated surface for damage arising from the same cause over the warranty term. If repair costs exceed the current average wholesale value of the treated vehicle, as defined by Black Book (published by Hearst Business Media) or similarly accepted industry publication, the average wholesale value amount will be paid to you and the remaining coverage under this warranty will end.
